Due to patent exclusivity (subject to change), biosimilars for Humira are not yet approved for these indications: Hidradenitis suppurativa in pediatrics 12–17 years; Uveitis in pediatrics aged 2 and older; and Ulcerative colitis in pediatrics 5–17 years.
